Event schedule has the time each segment starts.

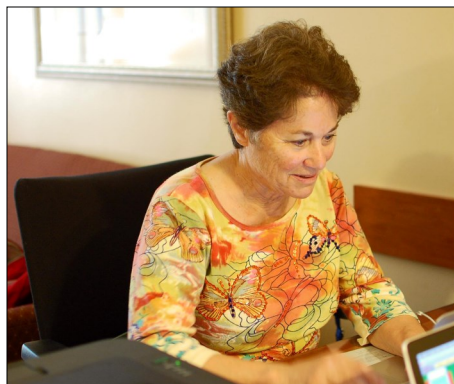
Daily Bulletin - links to the Daily Bulletins - if a link gets you a 404 error ("we can't find that page") that daily bulletin hasn't yet been posted.

The link will take you to a log in page that has been completely filled in for you. **Don't change your name or it won't work.** Just click on "Log In" and you will be taken directly to your seat at your team's table for the coming match. If you are taken to the lobby instead, that means you aren't scheduled to play the next match.

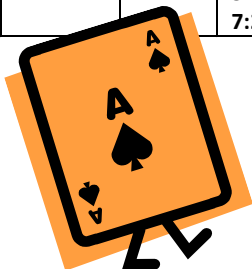

Ethics Statement

We're not trying to provide security for this event, as we do when we sometimes have "real" events online. However, the provisions of the USBF General Conditions of Contest regarding ethical obligations and possible penalties still apply to this event. The USBF has appointed an Ethics Investigation Committee that will review any complaints about ethics violations. If the EIC concludes that a player or pair was acting unethically, they will report to the USBF COO, who may refer it to the USBF Recorder. Either the COO or Recorder may bring a Charge against the player to the Board of Directors, who may place a player on probation, suspend, or expel a player for cause.

System Regulations & Conditions of Contest

- Normal USBF System regulations apply to this event.
- This event is governed by the USBF General Conditions of Contest and Special Conditions of Contest for this event.
- The ACBL Open+ Convention Chart applies to this event.

Kibitzing on VuGraph...

There will be delayed kibitzing for all of the JLall1 event.

To kibitz, go to <https://kibitz.realbridge.online/>, enter your name and click on Log In. That will take you to a screen where you can select the event to kibitz (*we do not know whether there will be events with delayed kibitzing other than the JLall1 running concurrently*).

After you select Kibitz JLall Online Teams #1, you will be taken to a lobby where you will see a list of tables on the left and a chat box and list of people in the lobby on the right. The table listing shows the team & player names at each table, as well as the board and trick that table is on (that's in the middle of the table, immediately under the table number). Click on a table to kibitz it.

At the table, you will see a hand diagram, and the bidding and play as it happens. You will not hear or see the players.

There is a chat window on the right of the screen (if your browser window isn't large enough to show it, you can click on the "chat" icon immediately above the UNDO button to open the chat window. For now, anyone can type chat into the chat window. We may have designated commentators for late stages of the event.

Some things you can do to get more information:

If there is an asterisk next to a bid, that means it was Alerted or Explained. Click on the bid to see the explanation if there was one.

-- "Rewind" the play using the slider underneath the "table" with hand diagram. just move the vertical handle on the slider to the left to go to earlier tricks.

-- Click on the "Scores" button to the left of the South player's name, you will get a scorecard for the match so far. You can use this to get lots of information:

----Click on a board number to see the hand record and results at all of the tables.

----You can also click on a number in a yellow box to get to the hand record from some screens.

----In the hand record screen, click on a result to see the bidding and play at a specific table.

--In the upper left corner:

----Click on the yellow box with 4 little boxes to get the match scores for all the matches (that will be IMPs and will not include scores from previous rounds).

----Click on the yellow box with 3 bulleted lines to get Cross-IMPs for the pairs (that will be just for this match).

The Scores information is also available in the lobby using the button at the upper right, in case you want to check on scores before deciding which table to watch.

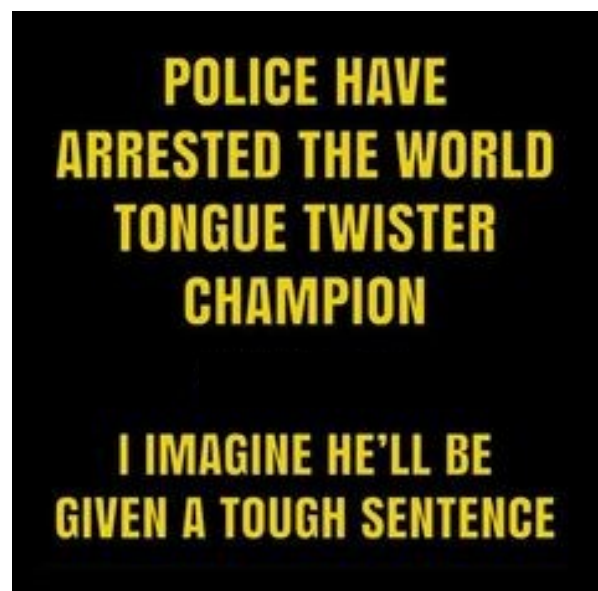
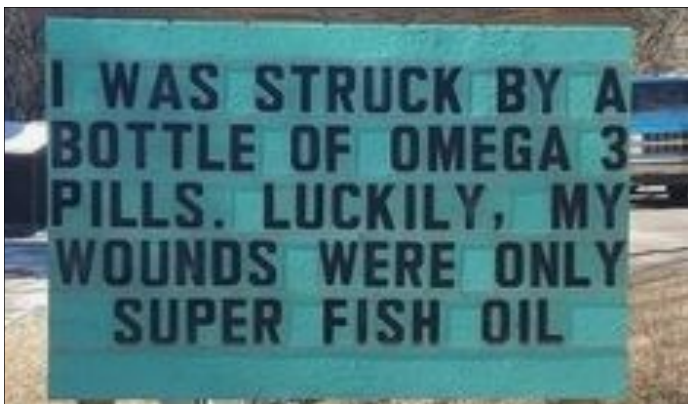
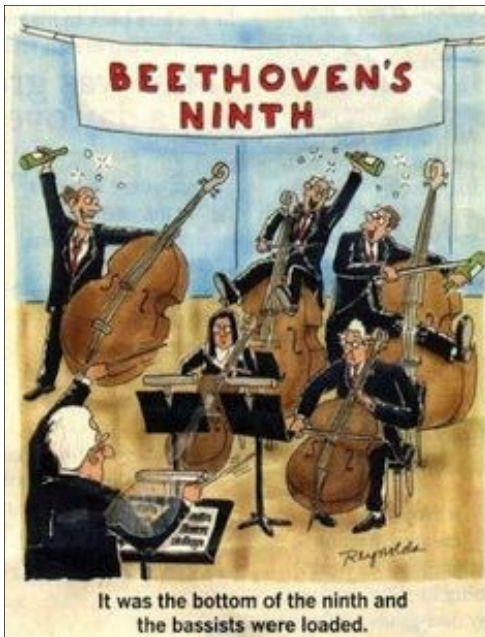

Lineups: For the Round Robin we are using “blind” lineups as we do for USBCs. You submit your lineup before you know which team you’re playing. **Lineups for the first 2 matches each day are due no later than noon EST.** After that, before each match starts, you need to submit your lineup for the following match. If you have not submitted a new lineup for a match, it means your lineup remains the same as for the current match. Lineups are submitted on a team lineup spreadsheet, which we have shared with your team's designated lineup person or people.

Starting Matches: Each match will be started as soon as everyone has logged in and is in their seats. When the match starts, EW players will automatically be moved to the opponents’ table.

Finishing Matches: When both tables have finished play, the EW players will be returned to their home tables and can go over the hands with their teammates. We need to close all of the tables from one round before setting up for the next one, so if your table goes away and you see a notice that says “Server Rebooted by Director” the time for the match and a brief comparison is over. If you are playing in the next segment, please wait until 5 minutes before that segment is scheduled to start to reload the web page, so your seating assignment will have been loaded and you will go to the correct seat.

Timing: We expect to be able to start each Round Robin match at the scheduled time, but there may be problems that mean we’ll be late - please bear with us!

Alerting & Explaining: You should self-alert & explain your own bids, and as with screens, should explain any bid if you have an agreement about it. If you explain a bid, it will show as being alerted, so you do not need to click on the Alert strip unless you want to alert but not explain. Note that your explanations appear in your “library” so you only have to type each explanation once; after that, you can just click on it. You can also provide additional information about bids orally to your screenmate. We hope that by game time you will be able to click on a bid and then on another button to ask the bidder for more information.

Undo’s: Undo’s for misclicks are allowed, and must be accepted. You need to ask for an undo before your partner acts. Both opponents must accept an UNDO request. If there is any issue about whether an UNDO should be accepted, please call the Director.

System Information: Use the Teams Entered page on the USBF website to access the opponents’ System Summary Form and Convention card. You can open those in a separate browser window or tab and have them available during play.

Asking questions of opponents: You may ask questions of either opponent by directing chat to them. You may ask your screenmate questions orally. PLEASE do not ask questions of the entire table, as that might give your partner UI. You may ask either opponent about any bid that was made by them or their partner.

Help during play: If you have a problem, click on the DIRECTOR tab and someone will appear at your table. That may be your real Director, Will Watson, or it may be me or Al Hollander - we’ll answer calls when Will is at another table and may be able to help or may have to tell you to wait for Will.

Scores: We will be entering scores into the USBF scoring software using the output from RealBridge, so we hope they will appear promptly and be accurate. In addition, you will see the scorecard at your table when you finish play, and you can also go to the lobby and click on the Scores button there to see the scorecard. Finally, the scores will be archived on the Kibitzer server, so you can go there to see the scorecards, bidding & play for everyone, travelers, and Butlers.

Pumpkin Spice Bread

Ingredients

- 3 cups sugar
- 1 cup vegetable oil
- 4 eggs, lightly beaten
- 1 can (15 ounces) solid-pack pumpkin
- 3-1/2 cups all-purpose flour
- 1 teaspoon baking soda
- 1 teaspoon salt
- 1 teaspoon ground cinnamon
- 1 teaspoon ground nutmeg
- 1/2 teaspoon baking powder
- 1/2 teaspoon ground cloves
- 1/2 teaspoon ground allspice
- 1/2 cup water

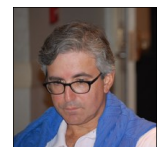
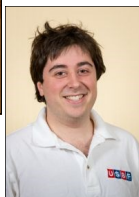


Directions

- Preheat oven to 350°. In a large bowl, combine sugar, oil and eggs; add pumpkin and mix well. In second bowl, combine the flour, baking soda, salt, cinnamon, nutmeg, baking powder, cloves and allspice; add to the pumpkin mixture alternately with water, beating well after each addition.
- Pour into two greased 9x5-in. loaf pans. Bake until a toothpick inserted in the center comes out clean, 60-65 minutes. Cool in pans 10 minutes before removing to a wire rack to cool completely.

Pumpkin Apple Muffins

Ingredients

- 2-1/2 cups all-purpose flour
- 2 cups sugar
- 1 teaspoon baking soda
- 1 teaspoon ground cinnamon
- 1/2 teaspoon ground ginger
- 1/2 teaspoon salt
- 1/4 teaspoon ground nutmeg
- 2 eggs
- 1 cup canned pumpkin
- 1/2 cup vegetable oil
- 2 cups finely chopped peeled tart apples



Directions

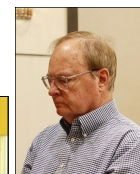
- In a large bowl, combine the first seven ingredients. In a small bowl, combine eggs, pumpkin and oil; stir into dry ingredients just until moistened. Fold in apples. Fill greased or paper-lined muffin cups two-thirds full. Bake at 350° for 30-35 minutes or until muffins test done. Cool for 10 minutes before removing from pan.

Turkey Pot Pie

Ingredients

- 2 medium potatoes, peeled and cut into 1-inch pieces
- 3 medium carrots, cut into 1-inch slices
- 1 medium onion, chopped
- 1 celery rib, diced
- 2 tablespoons butter
- 1 tablespoon olive oil
- 6 tablespoons all-purpose flour
- 3 cups chicken broth
- 4 cups cubed cooked turkey
- 2/3 cup frozen peas
- 1/2 cup plus 1 tablespoon heavy whipping cream, divided
- 1 tablespoon minced fresh parsley
- 1 teaspoon garlic salt
- 1/4 teaspoon pepper
- 1 package (15 ounces) refrigerated pie pastry
- 1 large egg

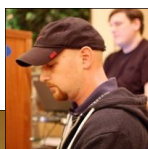


Directions

- Preheat oven to 375°. In a Dutch oven, saute potatoes, carrots, onion and celery in butter and oil until tender. Stir in flour until blended; gradually add broth. Bring to a boil; cook and stir 2 minutes or until thickened. Stir in turkey, peas, 1/2 cup cream, parsley, garlic salt and pepper.
- Spoon into two ungreased 9-in. pie plates. Roll out pastry to fit top of each pie; place over filling. Trim, seal and flute edges. Cut out a decorative center or cut slits in pastry. In a small bowl, whisk egg and remaining cream; brush over pastry.
- Bake 40-45 minutes or until golden brown. Let stand 10 minutes before cutting.
Freeze option: Cover and freeze unbaked potpies up to 3 months. To use, remove from freezer 30 minutes before baking (do not thaw). Preheat oven to 425°. Place pie on a [baking sheet](#); cover edge loosely with foil. Bake 30 minutes. Reduce oven setting to 350°; remove foil. Bake 55-60 minutes longer or until golden brown and a thermometer inserted in center reads 165°.

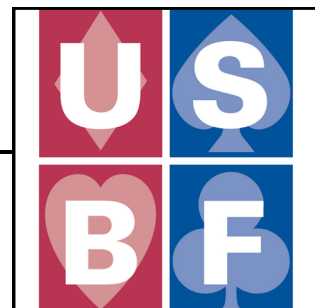

Alerts & Explanations

When it is your turn to bid, your bidding box appears above your hand. It looks like this:

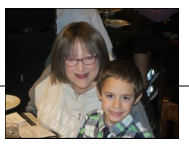

To Alert the bid you want to make click on the "ALERT" flag before you bid. To explain the bid you are about to make, type the explanation into the box that says "Explain bid here." The line below the explanation box has suit symbols - click on one of them to include it in the explanation or type ! and the initial letter of the suit. If the explanation you are about to make is one you made previously (for practice "previously" means during this session of play; we hope that for the real event it will include all previous sessions), you do not have to re-type it. Click on that square to the right of the club symbol to get to a library of previous explanations. Click on one to put it in the explanation box. Once you have explained and/or alerted, click on a bidding card to make your bid. You only need to alert if your are not explaining - an explanation without an alert will look the same to your opponents and in the bidding record as an explanation with an alert.

Board 8 on Wednesday night presented Stan (South) with tough decisions in both the bidding and the play. When 1S was passed around to him, he could balance with 2NT or double and then bid 2NT over North's response... or he could double, bid 3NT and play it there. IMPs is not for the timid and Stan is never timid. He doubled and when I bid 2C, he jumped to game.

Nick (West) showed his prowess on defense. He lead the SA and shifted to a small diamond. Ralph played the DQ and Stan won his ace. The CQ was ducked around and Katz gave count with the C6. The CJ was led and Nick accurately won the ace and exited with the DJ. Stan won the trick, cashed his hearts and exited with the D9. Katz won this trick, cashed the D2 and played a spade to Nick's king/jack, defeating 3NT two tricks. Accurate defense and slightly inaccurate declarer play combined for an 8 IMP loss.

3NT cannot be made once Nickell finds the diamond shift. Stan does best to cash his hearts first and then play on clubs. He can duck the second diamond and ultimately endplay West in spades for a one trick set. With BridgeBase IMP Pairs scoring, it would save one IMP.

Board 15 on October 28th is an offset to the hand above.

Stan declared 4S and won 7 IMPs with good card reading at trick one.

Nickell's opening lead was the C7. Dummy played the CJ and Katz played the CQ. Stan won his CK. He played four rounds of trump, putting pressure on East.

The opening lead looked to Stan to be a doubleton. This would mean that Katz held five clubs.

Katz pitched a club on the fourth spade. Stan played the ace of hearts and followed with a heart to the king and a third heart, trumping in hand. Ralph pitched a diamond. Stan played his last trump and Ralph was forced to part with a club. At this point, Stan led a club to endplay Katz. There was no need to guess the diamond!

Note that a 4H contract would have been easier because of the minor suit position. Declarer is able to draw two trumps and follow with three rounds of spades discarding a diamond when West trumps the third spade. The CK provides an entry to South's good spades.
