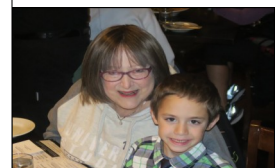

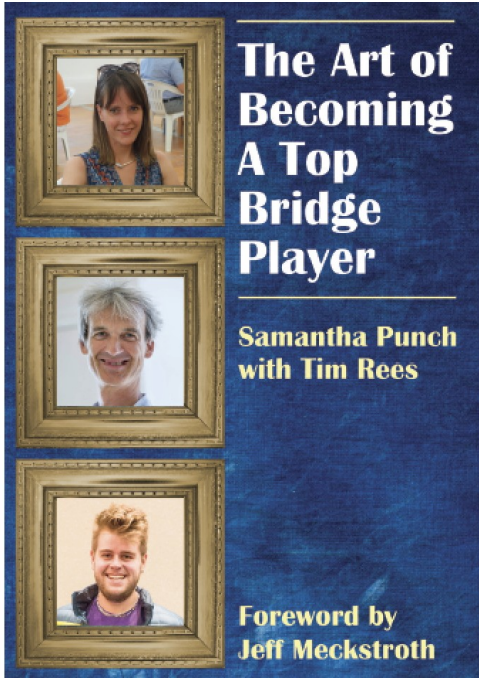

Master Point Press



This year, as we did last year, we will be tracking time used by each pair and penalizing a team if their pairs use significantly more than their allotted time. Each pair is allotted half of the session time, which is actually more time than they should be using, since some of the time at the table is "neutral," not charged to either pair. Pages 23 & 24 of the USBF General Conditions of Contest have the penalties charged; Appendix A has details of time keeping.

The penalty scale has been adjusted somewhat based on our experience last year, but the major change we've made for this year is in how time taken is shown to you at the table. Each player has a "pair clock" showing the amount of pair time remaining in the segment. The pair clock appears on the screen to the left of the table clock at the start of each board. The clock does not update during the bidding (otherwise it would provide information about which player on the other side of the screen was taking time) and I believe it is no longer visible during the play because that place on the screen is used for something else. The clock will be outlined in red if the time remaining is less than the allocated time for the remaining boards.

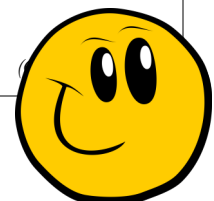

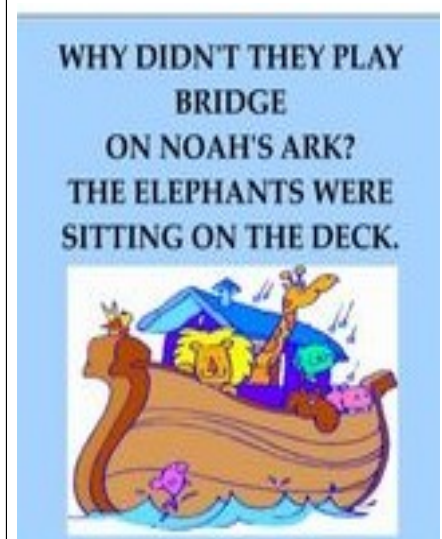

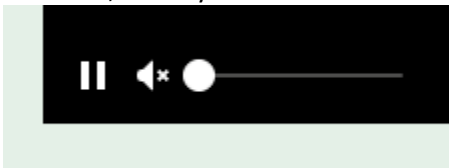

2024 USBCs Kibitzing - There will be delayed kibitzing for all of the 2024 USBCs on LoveBridge

You can follow the USBC on the <https://vugraph.lovebridge.com/> website. If you get to the voice commentary and there is no sound, you need to "unmute." When you first get to the page, there is a small icon of a speaker in the middle of your screen with an x on it. Click there to unmute. If you miss that icon, move your cursor to the bottom left of the screen and you should see a something like this:



Click on the speaker to unmute.

Vugraph is delayed for 30 minutes or until all tables have completed play on a board, whichever is later.

Kibitzing Schedule (EDT)

For all KO days of the 2024 USBCs, kibitzing times will be :

Segment 1: 11:30 am EDT; Segment 2: 1:45 pm EDT

BREAK

Segment 3: 5:00 pm EDT; Segment 4: 7:15 pm EDT

For Round Robin days, each kibitzing segment will start 30 minutes after play starts. No voice for RR's. To listen to commentary, search for the TV icon! It will send you to the page where you can choose from the available live commentators. If it doesn't do anything, no one is commenting.

Deep Involvement: Choose the "Match view" at the starting page of your event. Your screen will be divided into 4 small screens – 2 of them showing the 2 tables of the match you choose, the other 2 having the scoresheet for your match and the current scores of the other matches. In the 2x2 view you can personalize the content in all your windows. (The 2x2 view is not available on mobiles.)

Think together!

When watching a table, click on a name and choose "Kibitz". Instead of seeing all 4 hands, you will see what the player sees, and you can decide what you would do.

More Information:

Be well informed and tell your friends: while following the play, you can click many items. The image of the sticker with the number of the board (upper right) takes you to the results of the board, in the bottom right corner, the arrow takes you to the scoresheet, the DDS shows the double dummy analyses, beside that there is a button for the other table of the same match, at the top left corner you can see the bidding with alerts and the explanations (mouse over), the tricks already played, and the double dummy analysis for the available number of tricks with the par score.

Navigation icons:

While surfing here and there in the vugraph, or amongst the archive sessions, there are icons to help you. You can always go back to the main page with the "house" or to the standings with the "scores". If you cannot see the icons, move your mouse, or touch your screen and they pop up immediately. There is a built-in back button because the back button of your browser will always take you to the starting page. If this is not what you wanted, push next in your browser and you can continue where you were.

Replay:

After the event you can find every board from every table easily. While replaying the hands, the only surprise can be the way "next board" button works. If you have arrived from a scoresheet, it navigates through the scoresheet. If you have arrived from a screen where the results were shown for a given board, the same buttons move you through the list.

2024 USBCs Hospitality

We are returning to our pre-pandemic hospitality, with the hospitality suite (room 2321) open most of the day for socializing, Vugraph, and snacks. We will be providing breakfast and lunch each **day of play**. Marie-France Benoit will be our lead hostess, with help from Jacob Morgan and Julie Arbit, who makes the best guacamole. If you're at the tournament and can volunteer to help with hospitality (pick up items at Costco or nearby stores or restaurants, preparing food) please let Jan or Marie-France know.

Breakfast: From 8-10 am. There will be the usual breakfast food: cereal, bagels, toast, salmon, fruit, juice, coffee and tea. For those who prefer Keurig coffee, that will be available. So long as the suite doesn't become too crowded, you are welcome to eat there. No masking requirement.

Lunch: On the first four days of each event we will be serving a buffet lunch in a hotel banquet room, usually the Slate and Cyan rooms at the front of the hotel; we will have signs in the Player Break Room and Hospitality Suite with daily location. The hotel will be supplying what they do best: salads and chips. We will be bringing in 2 or 3 hot dishes from a local restaurant each day. There should be enough room for you to eat in the hotel banquet room, but you are welcome to take food from there to an outside table or to your hotel room. Lunch will be served from about half an hour before the morning session is supposed to end until about half an hour after the afternoon session starts. After the first 4 days of each event, lunch will be available in the hospitality suite at the break. There will be a main dish (sandwiches, chicken, main dish salads, pizza) as well as tuna salad, green salad, cheese, fruit, berries, cookies or other desserts. Water and soft drinks will be available in refrigerators. As with breakfast, you are welcome to eat in the hospitality suite unless it is too crowded.

Let us know if you have specific needs. Our hosts will do their very best to accommodate you.

Playing Rooms & Player's Break Room

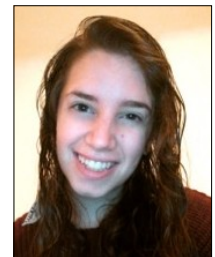
We will have bottled water in the playing rooms and if there is a refrigerator in a playing room we'll stock it with soft drinks.

We will have bottled water in the Player's Break Room (1321), as well as soft drinks, Nespresso, some packaged snacks, and some fruit. Please keep your voices down in the Break Room where we are working.

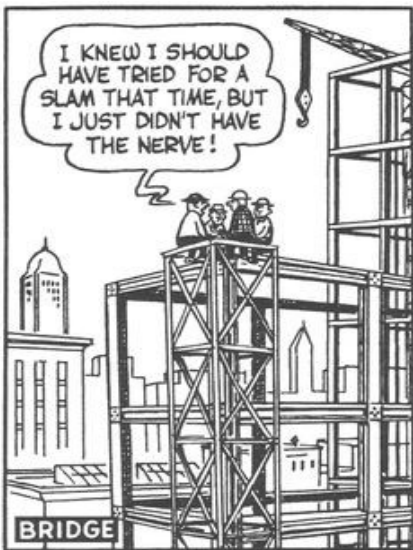

SAN FRANCISCO, June 28 — An upset was in the making when play resumed today at the International Team Trials, which determine the American teams in the world championships in October in Greece.

Top-seeded is the team headed by Nick Nickell, including Dick Freeman, Jeff Meckstroth, Eric Rodwell, Bob Wolff and Bob Hamman. They won the Bermuda Bowl eight months ago in Beijing, but here they face elimination. After 75 deals of a scheduled 120 in the semifinal, they trailed by 94 imps against Larry Robbins, Gary Cohler, Jerry Goldfein, Gerald Caravelli, Jack Oest and Steve Garner.

In the other semifinal, Zia Mahmood, Seymon Deutsch, Lew Stansby, Chip Martel and Michael Rosenberg led by 10 against Howard Weinstein, Ralph Katz, Peter Nagy, Bruce Ferguson, Fred Stewart and Steve Weinstein.

After 16 deals of a scheduled 96 in Women's Team play, a strong team headed by Kathie Wei-Sender led by 20 imps against a group including Dorothy Truscott. In the other match, two teams were in opposition. Juanita Chambers, Gail Greenberg, Jillian Blanchard, Irina Levitina and Shawn Quinn led by 17 against Judy Tucker, Karen Allison, Stasha Cohen, Lisa Berkowitz, Rozanne Pollack and Pam Wittes.

The Robbins team gained 47 imps in 15 deals, one of which is in the diagram. Wolff as East opened two clubs, a natural bid with limited values, and the bidding reached the five-level. He bid five no-trump to show a good hand, and his partner, Hamman, doubled six spades.

The lead was crucial. If Hamman had led a diamond, it would have been all over. But he made the nor-

He concluded that Wolff was likely to have the heart queen, so he led to dummy's king, ruffed a heart and was rewarded. Dummy's jack was established, and a club ruff permitted him to lead that card and discard his diamond loser.

Making the doubled slam gained 14 imps. In the replay, the contract was five spades, making six.

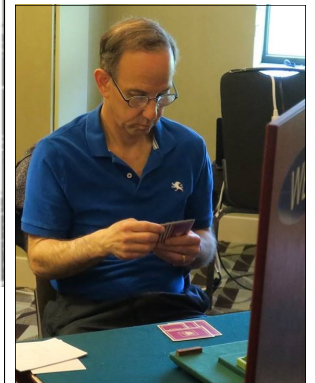

Playing Procedures Reviewed For Those Arriving for the Mixed, Seniors, Womens

You will be playing on Chromebooks using LoveBridge software. The Chromebooks all have wired mice, which you may choose to use or not. They also have touch screens if you prefer that, and of course integrated keyboards. You will not be able to go to any websites other than the LoveBridge playing site from the playing room Chromebooks.

There will be 2 players in each room, one from each team in the match - North & East together and South & West together. All of the NE rooms are on the first floor; all of the SW rooms are on the second floor.

Because some of you have said that you prefer the opponents' system information on paper in addition to being available on the Chromebooks, we are asking each player to bring a copy of their SSF, convention card, and if relevant the ACBL Multi defense to the table for their opponent. If you need help printing anything, come to room 1321 before you play and one of us will print for you.

After you have finished a segment and scored with your teammates, please check the score on LoveBridge and if you disagree with it, come to room 1321 and so we can sort it out.

Captains:

Your lineup sheet been shared with you. If you can't open it, or don't understand something about it, please let us know.

For the first segment of play each day, the Away team (the team that does not have seating rights for the segment) should tell the Home team their lineup (by email, text, or an entry on the lineup sheet) no later than 8:50 am (70 minutes before play starts), and enter the lineup on their lineup sheet no later than 9:00 am. If you enter your lineup on the lineup sheet before 8:50 am, that will satisfy both requirements. The Home team should give the Away team its lineup by 8:55 am, and should also enter it on the lineup sheet no later than 9:00 am. Of course, if the Away team doesn't communicate its lineup on time, the Home team has more time.

We ask you to enter the lineup on your lineup sheet because that may be the easiest way to give your lineup to your opponent. If you leave your lineup page open on your computer or other device, it will automatically update with the opponent's lineup when they enter it. Also, especially for the first segment of the day, there are often players who come to the office asking where they're supposed to sit and if the lineup is on the lineup sheet, we can direct them.

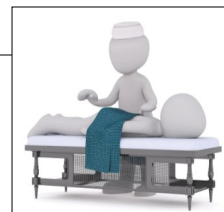

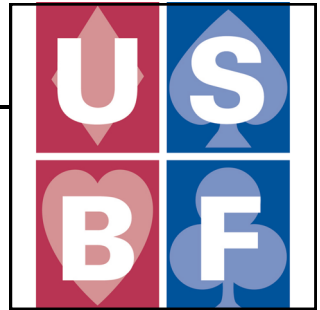

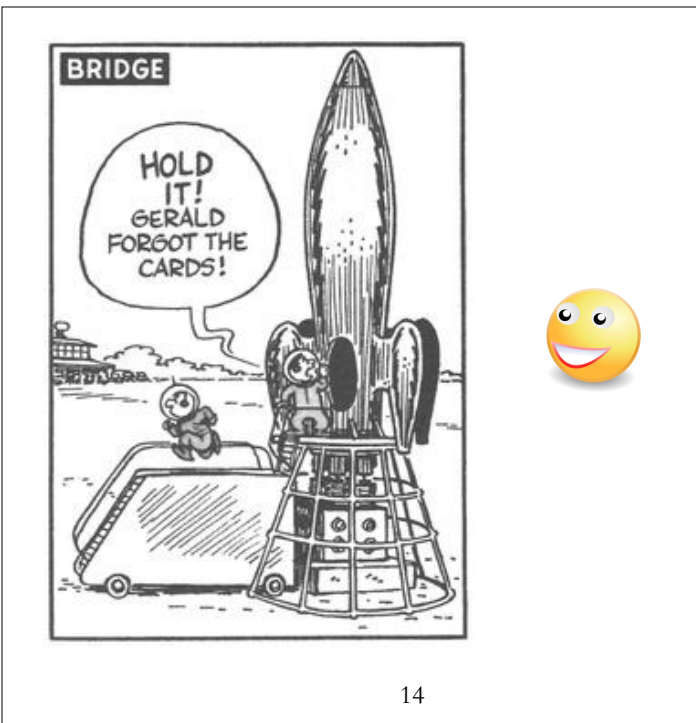

Board 4 is one of those hands (and it's in the extreme) where declarer if East will bring in 12 tricks in 3NT, but if West, can only take 7 on best lead from North.

At the tables, seven pairs played 3NT from West. Only one declared from East. Six of those seven who declared from West succeeded with overtricks. One failed!

The only lead to defeat 3NT is the DQ from North.

In Millens/Ding where 3NT was defeated by Lin-Huan Chen and Ding-Hwa Hsieh, the opponents employed a puppet stayman bid of 3D that allowed South to double and made it easy for North to find the DQ!

Many would not have bid 3D on this 4-3-3-3 hand even if it were in their arsenal, thinking that a 9-trick game might be easier than a 10-trick game with no ruffing values.

To that point, Kislitsyna/Chan in the Rosenthal/Ivatury had a simple 1NT-P-3NT-All Pass auction where Michael Rosenberg led a "normal" spade. Giorgia Botta and Zach Grossack had the same auction in Pollack/Rubenstein and Bill Pollack led the H4.

Without help from South, it is very difficult for North to find the lead of the DQ.

On many hands this would have been moot because South would not hold a decent 6-card diamond suit and would have no double. On this hand, it was a perfect storm for Millens... N/S held the magic lie in diamonds AND they had a convention that fit their hands but gave the opponents a chance to exchange information they never could have without it.

Looking at the scoresheet, the lack of swings makes Board 7 look flat. it really isn't. Six pairs played in the heart game N/S while two bid and made the cold slam.

Declarer was destined to take 12 tricks with hearts splitting 3-2 and both the DK and SQ onside.

When Debbie showed what she had, Michael made one last ditch try with 5NT. With less than 3-card support, or minimum values, Debbie could pass 5NT and play it there.

As it was, her values looked prime and she accepted the slam try.

At the other table in that same match, Quinn also opened 2NT. Graves also transferred. Quinn superaccepted by jumping to 4H and Graves asked for keycards.

Shawn showed 2 without the queen and Graves bid the slam.

Percentage-wise, slam isn't a great contract requiring so much to be right, however, aggressive vulnerable games and slams win matches!

In this case, bidding it at both tables in the same match pushed the board preventing a loss!

Board 9 is one of the swingiest boards in the event so far.

In every match, one or two tables played doubled.

There were no legitimately makeable games.

Seven declarers went down in whatever they played. Only one declarer in the field was successful!

Defending 3NT, South was licking their chops, anxious to lead a club. They couldn't and shouldn't consider a double for fear the opponents would run. As we can see, N/S scored +200 consistently vs. the NT game!

At the two tables where 5D was played, the contract went down 3 doubled and vulnerable. At the tables playing in hearts, 5H fared the same. 4HX went down one in Rubenstein/Pollack while in Zhang/Lewis, Larry Robbins became the only declarer to get a positive score. Korbel led the DA and Robbins ruffed in hand.

Robbins played the H4 to the 3, J, and Q. Sylvia won and could play any non-heart card to defeat 4HX! A non heart switch taps declarer and prevents him from getting to hand to enjoy his clubs.

Alas, Sylvia played the HA and switched to a club. Robbins won it, stripped Shi of her hearts and ran his clubs for +590.

It is easier for us to play a non-heart when seeing all four hands. Without knowing declarer's clubs were solid, Shi's play is reasonable. 9 IMPs to Lewis
