History of the

Chicago Mercantile Exchange

The Chicago Butter and Egg Board was founded in 1898 and evolved into the Chicago Mercantile Exchange in 1919. At that time, futures contracts were offered only on agricultural products. Since:

1961: A frozen pork belly futures contract, the first futures contract based on frozen, stored meats.

1964: A live cattle futures contract, the first futures contract to be based on a nonstorable commodity.

1972: The world's first financial futures with futures contracts on 7 foreign currencies.

1981: CME® Eurodollar futures, the first contracts to be settled in cash. They became the world's most actively traded futures in 2002.

1982: The first successful equity contract, the CME S&P 500® Index futures contract.

1984: The first international link between futures exchanges - a mutual offset trading link between CME and the Singapore Exchange Derivatives Trading Ltd.

1992: CME Globex®, the first

global electronic futures trading platform. It originally proafter-hours trading. Now it offers trading 23 hours a day, five days a week.

1997: CME E-mini® S&P 500 contracts electronically traded products that are 1/5 the size of the standard S&P 500 Index futures, paving the way for additional E-mini products.

2000: The first demutualization of a U.S. financial exchange achieved by converting its membership interests into shares of common stock that can trade separately from exchange trading privileges.

2001: The formation of CME Holding, Inc., the parent of CME, providing business and strategic flexibility. CME became the largest futures exchange in the U.S.

2002: CME Holdings stock is listed on the NYSE, making CME the first publicly traded U.S. financial exchange.

2003: CME and CBOT implement a common clearing link under which CME provides clearing and related services for all CBOT-traded contracts.

USBC/USWBC ROUND ROBIN SCORING from Jan Martel

Scoring for the Round Robin in the USBC and USWBC this year will be done by the program on our website, based on score sheets that the North player completes at each table. For those of you who played in the USBC last year, the score sheets will look about the same as they did then. However, there is a significant difference this year – these are now **official score sheets** and **must** be turned in before you can start your next match. Although you will have an opportunity to correct an incorrect score later, it will be much easier for everyone if you are initially accurate. Please check the results with your opponents at the end of each match before turning in the score sheet.

After each round, the scores on the score sheets will be entered into the computer and the computer will calculate IMPs on each board and VPs for the match. These results will be posted online and in addition we will print a scorecard from the match for each team. The VP results will be entered on a cross-table (two for USBC Round Robin 1 which will have two divisions) on the USBF website. We will have computers with overhead projectors in the lobby areas of both the Open and Closed rooms that will project these cross tables on the wall.

If you disagree with a posted result, you must find the captain of the opposing team and the two of you must submit a score correction to one of the DICs, within one hour after the session in which the match was played.

USBC Round Robin Lineup Submission Procedure

This year, as for the last few years, we will be using a "blind" lineup submission procedure for the USBC Round Robin. This means that you will not know you opponents for a match until after you have submitted your lineup. Before each "clump" of matches, you will hand your lineup in to one of our logistics staff (Jan, Rena, Jeff or Tom) and he or she will give you your guide cards for the matches in that clump.

With the exception of the final clump of 4 matches in RR2, you may change your lineup between matches of a clump in either the Open of Closed Room. During the final clump of 4 matches in RR2, the Closed Room teams will be sequestered and may not talk to their teammates. No substitutions will be allowed in the Closed Room during those matches. You may make substitutions in the Open Room at any time. Note that the substitutions must be included on the lineup you submit for each clump. You may make substitutions during a match or clump **only** for emergencies and with permission from a DIC.

USBC FORMAT AND MISCELLANEOUS INFORMATION

The ITT Conditions of Contest Committee has approved the following format for the USBC Round Robin: The 22 teams playing in the Round Robin will be divided into two 11 team groups of roughly equal ability. Each team will play a 7 board match against each other team in its group. These matches will be played on June 1st and 2nd. The IMPs in each match will be converted to VP's using the USBF 7-Board VP Scale. At the conclusion of this RR, the bottom 3 teams from each group will be eliminated. The remaining 8 teams from each group (16 in all) will complete RR play. Each continuing team will play a 7 board match against each continuing team from the **other** group, on the second half of Saturday, June 2nd, and the first half of Sunday, June 3rd.

After completion of play, each of the continuing teams will have played a 7 board match against all other continuing teams. In addition, each of the continuing teams will have played 3 matches against eliminated teams. The continuing teams' final scores will be the full VPs earned against other continuing teams, whether those VPs were earned in the first day and a half of play or in the final day of play, plus a percentage of the VPs they earned against the eliminated teams. That percentage will depend on the scores of the eliminated teams - VPs earned against a team that did better will count more. The Round of 16 will start the afternoon of Sunday, 6/3, and take 1 1/2 days. Each of the Quarterfinals, Semi-Finals and Finals will take two days. See the tournament schedule on page 10 for exact times of each session of play.



An Interesting Hand from the Recent District 13 Regional Knockouts

South opens 44 and everyone passes. The opening lead is the diamond king, followed by a diamond to the ace and a third diamond. You ruff this. What is the best line of play?



You appear to have a heart loser and a potential spade loser. A simple line would be to lead a heart to the king and finesse for the king of spades. This line works when RHO has the singleton or doubleton king of spades or if the queen/jack of hearts fall. It appears, however, that the spade finesse is the wrong finesse to take. You should instead lead a heart to the king and lead the king of clubs off dummy. If RHO has the ace of clubs and covers, you now ruff and lead the queen of spades. Either opponent holding the king doubleton or singleton of spades will be forced to win this trick and you will be able to use the jack of spades as your entry for a heart discard. If RHO fails to cover, you simply discard a heart. If RHO has the ace of clubs, the hand is over... you simply play on spades. If LHO has the ace of clubs, your heart loser has gone away and you have to hope one of the opponents holds the singleton king of spades. This way you have combined the finesse with the drop of the spade king and increased your chances for success.

Now put yourself in the East seat. How do you defend to beat the contract? Based on partner's play in the diamond suit, you discern that declarer has no more diamonds. If his spades are solid, you can only beat the hand if partner has both side aces, and in that case, you will automatically succeed. Therefore, you must hope that partner has a spade trick and one of the side aces. If you continue diamonds, declarer will ruff, cross to dummy's king of hearts and take the combination play of a ruffing finesse for the ace of clubs or a drop of the single-

ton king of spades. This will succeed when your partner's singleton king drops.

The only defense that will beat declarer is a club shift!! Since declarer knows the club play will fail, he will give up on that line of play and simply finesse for the king of spades, losing to partner's singleton king and allowing your side to eventually score a heart trick.

Thanks to the generous support of the **Chicago Mercantile Exchange**, the USBC will be covered on the Bridge Base Online Vugraph starting with the Round of 16. In the Round of 16 we will be covering either 2 or 3 of the ten matches being played. From the Quarterfinals on, we will cover all of the tables in play. To watch the Vugraph online, go to the BBO website and download the BBO software. Install the software on your computer, log on, follow the directions to become a BBO member (it's free!) and you'll be magically transported to the Lobby of the largest bridge club in the world. Click on the button labeled EXPLORE BRIDGE and then on the button labeled VUGRAPH THEATRE and you'll be able to choose which of the USBC matches you want to watch.

There will be a "yellow" user on BBO called USBF. If you have general questions, please ask USBF, not one of the hardworking Vugraph Operators, who may be too busy to respond to private messages. Thank you.

During the Quarterfinals, Semifinals and Finals, all of the teams will play the same boards, unless one or more matches gets sufficiently far behind that it has to start later than the other matches, in which case, for security reasons, the teams involved will play different boards.

During the Round of 16, all of the teams will play the same boards in the first and third segments each day. In the second and fourth segments, those matches that start on time will play the same boards. We will try to have all of the tables shown on Vugraph be ones that play the same boards.

After a session, you can review the Vugraph action on our Web Vugraphs, which show each hand played with a link to bidding and play records. Take a look at the older events currently available to see what we'll have for the 2007 USBC. Web Vugraphs are posted within about half an hour of completion of the Vugraph show.

Screen rules:

Only N or S move the tray.

No verbal questions or explanations. Claims, calls of cards from dummy, etc should be whispered. This is an absolute requirement in the RR stage because all the hands are the same. In the KO stages all the hands are the same, but you will play in individual hotel rooms.

The alert card or tab should be put on top of the alertable bid and removed when the bid is made or the alert seen. It is your responsibility to make sure your opponent knows you have alerted.

Prior to the opening lead the opening leader is permitted to ask for clarification, in writing, from her opponent on the other side of the screen.

After the final pass, the declaring side may initiate an exchange of information about their own explanations (if misinformation is discovered, the auction may be reopened).

The opening lead is made face down. Opening leader's screen mate announces the opening lead has been made (or knocks on the screen) and a defender raises the screen.

During play any questions (only in writing) must be asked and answered with the screen closed.

Play requirements:

Important: For the last two matches of the RR on Saturday pairs in Section BB will be sequestered and play straight through. Plan for this when you schedule when each pair is going to play. You will meet the teams in the same order on both days.

Each pair must play at least 8 boards in the RR against all other teams.

In each match of the RR, the team that did not have the seed the first day has the seed the second. Your guide cards should have an asterisk to designate that you have the seed.

Time penalties:

If you are one minute late the penalty is 1 IMP/VP, so please be prompt. Penalties escalate.

In the RR stage you do not have the right to compare if the next match is starting. If you used up most of your time in a match and need a smoke/bathroom break, take it before comparing if you have another match to play. Players should not have to take a break during any RR match.
